PAYMENT ASSESSMENT

Under Sections 1-3 of the Membership Rules of the Studierendenwerk Freiburg-Schwarzwald as amended by the Board of the Student Council on 27.06.2016 in conjunction with Section 12 (2) and Section 6 (1) of the Studierendenwerksgesetz (StWG, Student Council Act) to cover the costs of the Studierendenwerk and the option of using the ÖPNV SemesterTicket for the **2019 summer semester**, you have to pay the sum of

€78.00

to the bank account given below. This sum comprises a membership contribution of €56.00 to the Studierendenwerk and a contribution of €22.00 towards the basic costs of the SemesterTicket travel pass. This basic contribution entitles you to acquire the ÖPNV ticket, which is valid for one semester, and is passed on in full by the Studierendenwerk to the Freiburg regional transport authority.

From the membership contribution of €56.00 the Studierendenwerk finances amongst other things the following institutions and activities:

- the general activities of the Studierendenwerk
- the canteens and cafeterias
- the student loan association and the hardship fund
- insurance policies
- crèches
- psychotherapeutic counselling
- the advice center
- accommodation and employment services

The contribution is a "Solidarbeitrag", a payment which is compulsory for all students.

Students on leave of absence are only liable for the membership contribution of €56.00. The €22.00 fee for the SemesterTicket is not levied (however please note that the SemesterTicket cannot be purchased).

Your Legal Rights

You may object to this decision within one month of notification, by writing or making formal declaration for the record to the Freiburg Student Council, Schreiberstraße 12 - 16, 79098 Freiburg. Under Section 80 (2) VwGO such objection does not defer the effect of the decision.
